Deadlines- Entry deadline is June 20th, postmarked date, for all entries. Junior members showing Futurity lambs may submit entries by 30 June. Late entries will be accepted at double the entry fee.

Entry Fee- Open show entry fee is \$20 for each individual animal, \$10 for each group class. Wool show entry is \$3 for each fleece. The Junior show entry is \$10 per animal. 80% of the total entry fee for each class will be paid-back in premiums to that class. Make checks to Adams County Extension – National Show

Registration Papers- All entries must be registered at the time of the show in the exhibitor or immediate family member's name. Registration papers must be presented at time of stalling.

Health Papers- All sheep must have both flock and scrapie tag numbers on health certificates that have been completed within 30 days prior of the show. All sheep must be free of clinical signs of sore mouth, foot rot, caseous lymphadenitis, blue tongue, scrapie, club lamb fungus, and lice.

From the North:

Merge onto I-25 S/US 87-S. Take the E-470 Tollway Exit - EXIT 228 toward Limon/Denver Int'l Airport. Merge onto E-470 S (portions toll). Take the US 85 exit - EXIT 38 toward Brighton/Commerce City/I-70 Denver/Fort Morgan. Merge onto US-85 S towards Commerce City. Turn right onto East 124th Avenue/CO-22. East 124th Avenue/CO-22 becomes Henderson Road. End at 9755 Henderson Road.

From the South:

Take the E-470 N. Ramp. Merge onto E-470 (portions toll). Merge onto US-85 via EXIT 38 towards Commerce City. Turn right on 124th Avenue/CO-22. East 124th Avenue becomes Henderson Road. End at 9755 Henderson Road.

Directions from the West:

Take West 120th Avenue/CO-128 East. Turn left on Holly Street to 128th Avenue. Turn right on 128th Avenue. Turn right onto Riverdale Road towards 124th Avenue. Turn left onto 124th Avenue. End at 9755 Henderson Road.

Directions from the East:

Merge on I-70 West/US-287 N/US-36/US-40 W. Take the E-470 Tollway exit, EXIT 289 towards Ft. Collins/Colo Spgs/Denver Int'l/Airport/Gun Club Road. Turn right onto E-470 N. (portions toll). Merge onto US-85 South via EXIT 38 toward Commerce City. Turn right onto East 124th Avenue/CO-22. East 124th Avenue/CO-22 becomes Henderson Road. End at 9755 Henderson Road.
