

Dear Rambouillet Futurity participant

Congratulations on the purchase of your futurity ewe lamb for the 2011-2012 Futurity Program. Enclosed are the Futurity Program rules, the new rules for this year and the forms for reporting futurity placings. These rules are in response to the board of directors decision that the futurity program must be financially self-sustaining. The following rules are the changes to the futurity program.

- 1) The James Steen yearlong futurity program will be funded by the nomination fees paid by the breeders at the time of sale. The amount of \$1500 will be awarded each year for this portion of the futurity program. In years in which there is an excess of \$1500, the excess amount will be held for use in years when there may be a shortfall of funds.
- 2) The Jackpot Comeback Futurity Ewe Show will be funded by an entry fee of \$30 per head paid by the Juniors owning the ewe lambs. Entries for this class may be made at the same time as Junior entries are sent in for the National Show or up to the start of the Open Show during which the Jackpot Show takes place. Exhibitors are limited to entering and showing no more than two futurity ewes in this show.
- 3) The comeback show will be funded using these exhibitor entry fees. If additional donors are found, these funds will be used as well. If no additional donations are secured, the payout will be based entirely on the Junior entry fees. The payout will be based on the same sliding scale as used in the Yearlong Futurity Ewe Lamb competition.

Please review these changes to the futurity program. If you have any questions, please contact Burk Lattimore, ARSBA Secretary. Good luck, and we look forward to seeing you in Utah for the 2013 ARSBA National Show and Sale.
