

Instructions for Animal Registration Form

Column Explanation

- KHSI#** Do not enter - Registration/Recordation number will be assigned by KHSI
- Flock Prefix & Sheep ID** . . Numbers/letters on ear tag, tattoo unique to individual (including flock of origin prefix); record this number exactly as it is on the animal.
- Date of Birth** Month/day/year of birth of animal being registered or recorded
- Sex** R=ram or E=eewe
- Birth Type** Of animal being registered/recorded; 1=single, 2=twin, 3=triplet, etc.
- Sire KHSI Reg.#** Registration/recordation# of sire; upper right corner of sire's KHSI certificate
- Sire ID** Flock prefix & Sheep ID of sire
- Dam KHSI Reg.#** Registration/recordation# assigned the dam by KHSI (upper right corner of certificate)
- Dam ID** Flock prefix & Sheep ID of dam
- KHSI - %** Do not enter - percentage Katahdin blood for Recordations will be assigned by KHSI Registry

Do not enter the following fields unless you are a current KHSI Inspector

- Coat Do not enter - Type A, AA, B, C can only be assigned by a current certified KHSI Inspector.
- Poll Do not enter - P=poll, S=scurred, H=horned can only be assigned by a current certified KHSI Inspector
- Inspector Comments Do not enter - Space for inspector to sign. To validate the inspection, the inspector is required to write the date of the inspection, legibly print name and legibly sign name (no initials).

Owner is the membership name of party owning animal at time of registration (NOTE: if different than flock of origin, transfer fees will apply)

Breeder is membership name of party owning Dam at time of breeding

Flock of Origin is party owning Dam at time of lambing. Their Flock Prefix will apply to lambs. This party must complete and sign the Animal Registration Form.

¹ – Note - There is no separate family membership category. The voting membership category allows registering of sheep in the name of the individual member, business/corporate/partnership/family member or allows families and partnerships to register sheep in the name of individual members of the family or partnership.

² – Youth membership is for individuals that are less than 19 years of age. It is valid until January 1st following the 19th birthday. Youth membership provides all the benefits of the regular voting membership except voting privileges. Youth Members can register, record and transfer sheep at member prices, but youth membership is free. NOTE: Youth may have their own separate membership and flock prefix or they can be part of their Family's **Voting Membership**. If part of the Family Membership, youth can still register sheep in their name using the Family's Flock Prefix. If part of the family membership, a separate youth application should not be filed.

³ Transfer fee applies when Owner on application for registration is other than Flock of Origin.
