Dear National Tunis Sheep Registry, Inc. Member,

Enclosed you will find the entry form for the 2017 Stars of Louisville Sale. Currently we have approximately 20 head from 9 consignors who are planning on selling sheep at this sale at the North American International Livestock Exposition. The sale is scheduled for Saturday, November 11, 2017 at 7:00pm. A show will precede the sale to determine sale order, judge is TBD.

- It is open for ewes who are 4 years of age and younger.
- Those ewes who are not eligible to be shown cannot be penned inside the NAILE sheep area
- Consignors may reserve the right to show any eligible sale animal during the Tunis show on Monday, November 13th at 8:00am. Any sheep that is retained for the show will be released to the buyer following the completion of the show. Retained show rights must be announced during the sale. Transportation details of any retained ewe will be arranged by the buyer and seller.
- Classes offered are as follows
 - Aged ewe (4 years old and younger)
 - Yearling ewe
 - Senior/fall ewe lamb
 - Spring ewe lamb (classes may be split after entries are received)
- All consignments must have a health paper that meets the requirements of the State of Kentucky. A separate health paper must accompany each animal. Please note that the consignee on your health paper should be the "Stars of Louisville Tunis Sale".
- Entry fee is \$25 per head. A commission of 11% of the selling price will be deducted from your sale settlement. Transfer fees will be deducted from the consignor's settlement.
- Every entry shall have a registration paper at sale time and turned into the sale management prior to the show.
