Friday, November 12, 2010, 7:00 p.m.

1. The following breeds will be included: **Hampshires, Dorsets, Southdowns, Montadales, Shropshires, & Suffolks**. Registration papers will be required for these breeds. There will also be a class for **Commercial - cross-bred - unregistered purebred ewes**. All ewes selling without registration papers will be classified Commercial. Example: They will be entered on the Sale Order as *Yearling Ewe* or *Spring Ewe Lamb*. Only entries with registration papers will be classified by their breed. Example: They will be entered on the Sale Order as *Hampshire Yearling Ewe* or *Hampshire Spring Ewe Lamb*.

2. Classes may be entered as follows: Yearling Ewes, Fall Ewe Lambs, and Spring Ewe Lambs.

3. Each consignor is limited to ten (10) head **per breed**.

4. If registered ewes are sold as bred, the registration paper must be accompanied by a breeding certificate or the pertinent information included on the back of the registration paper.

5. Sale sheep must be slick shorn, clean and tag free.

6. All consignments must be accompanied by a health paper which meets the requirements of the State of Kentucky. For complete health regulation information go to www.kyagr.com or call the Kentucky Department of Agriculture, State Veterinarian 502/564-3956

A separate health paper is required for each animal -- each animal must have a federal scrapie tag

Note: the Consignee on your health paper should be Market Lamb Mamma Sale, not NAILE

7. Sale order determined as follows: Descending order of best average in either of the two previous Market Lamb Mamma Sales by previous consignors. New consignors will sell in order of entries received. Each consignor will sell one sheep in the first round and may elect to sell one or two sheep (3 head if more than 6 entries) in the successive rounds at his discretion. Sheep of poor quality or questionable breed type may be disqualified by a sifting committee and not permitted to sell in the sale.

8. An entry fee of \$20 per head and 11% commission of the selling price will be charged. Commission will be paid by consignor even if entry fails to sell. Entries postmarked after entry deadline will incur double entry fees. Transfer fees, if applicable, will be deducted from the consignor settlement.

9. You may include one photo with each of your consignments (approximate size 2 1/2 x 2 1/2 inches) along with up to 3 lines of copy.

10. **Entry deadline is October 1, 2010.**
